

Harmony Spring Privacy Policy

The privacy of all “Users” (You, our customer) of all products or services offered on HARMONYSPRING.COM is of primary importance to our company. We are committed to protecting the confidentiality of all information entrusted to us by Users. We may, from time-to-time, collect Personal Information from Users. This includes name, address, and email address information that you provide, and any product orders and correspondence that you have with HARMONYSPRING.COM. Our policy states that information collected from you on our state of the art secure database will not be redistributed or sold to anyone outside of Harmony Spring.

Your Consent:

PLEASE NOTE that your provision of Personal Information to HARMONYSPRING.COM constitutes implied agreement and consent to our collecting, using and disclosing of your Personal Information in accordance with our Policy. If you do not agree with these terms, do not provide any Personal Information to HARMONYSPRING.COM. However, many services, such as the delivery of our products, newsletters, and new product information, can only be offered if you provide Personal Information to HARMONYSPRING.COM. Consequently, if you choose not to provide us with information essential for the provisions of these services, we will not be able to offer them to you. If you do not wish to receive information regarding the products and services offered on HARMONYSPRING.COM, send an e-mail to the address listed at the end of this policy requesting that you do not receive any correspondence from HARMONYSPRING.COM for any products and services offered by us.

How We Use Personal Information:

We may, from time-to-time, use Personal Information collected through this website to provide Users with a product or service that has been requested and/or to contact Users directly regarding products and services offered on HARMONYSPRING.COM. Our use of Personal Information is limited to these purposes. We will use all information collected from Users for the Permitted Uses only, except as mandated by law. We do not sell or otherwise disclose to third parties any Personal Information that we have obtained.

Additionally, there are circumstances where the use or disclosure of Personal Information may be justified or permitted or where we are obliged to disclose information without consent: Those include (but are not limited to) circumstances in which the collection, use or disclosure is clearly in the interests of the individual and consent cannot be obtained in a timely way; the personal information is available to the public from a prescribed source; and/or the collection, use or disclosure of personal information is required or authorized by law. Where obliged or permitted to disclose information without consent, we will not disclose more information than is required.

Maintenance and Security of Personal Information:

Personal Information about Users that is maintained on our systems is protected using industry standard security measures. However, although we will make all commercially reasonable efforts to keep your Personal Information secure, we cannot guarantee that the information submitted to, maintained on, or transmitted from our systems will be completely secure and transmission of information over the Internet is susceptible to possible loss, misrouting, interception and misuse. Please keep this in mind when deciding whether or not to provide your Personal Information.

Access to Personal Information:

If an individual believes that their Personal Information on file is not correct, individuals can access the HARMONYSPRING.COM Account Information section that allows individuals to view and update all of their Personal Information at any time.

Amendment of Our Practices and this Policy:
